

## Grocery Store Licensing Guide

The Kansas Department of Agriculture is devoted to the total support of agriculture in Kansas. While we must fulfill our statutory obligations, the department is dedicated to providing support and assistance to make Kansas farms, ranches and agribusinesses successful and help them grow if that is their desire. We also encourage more farms, ranches and other agriculture business to expand in or relocate to Kansas. This checklist will help guide you through various resources and requirements for opening and operating a typical Kansas grocery store. In addition to license requirements by the Kansas Department of Agriculture, other Kansas agencies as well as local or federal government agencies may have regulatory requirements to follow. Contact your local planning authority to ensure you follow all local business development laws, rules, regulations and guidelines. This guide is designed to assist you as you work to build and operate a successful grocery store in Kansas.

	Office of the Secretary of State	Complete the appropriate <u>filings and forms</u> for a business entity required by the Kansas Secretary of State. Call 785-296-4564 for more information.	Prior to starting
	Department of Revenue	Visit the Department of Revenue website to find important <u>business tax information</u> . Review all pertinent information about <u>Cigarette/Tobacco Products</u> . A <u>retail counter cigarette license</u> is required for any business selling cigarettes over-the-counter. The license fee is \$25 for each location and must be renewed every two years. 	Department of Agriculture, Food Safety & Lodging	Complete the <u>Food Establishment License</u> . For more information, visit the <u>Food Safety &amp; Lodging</u> website, or call 785-296-5600.	Prior to starting, Before April 1
	USDA Food and Nutrition Service	Apply online to accept Supplemental Nutrition Assistance Program (SNAP) benefits at your store, or call 877-823-4369.	Reauthoriza- tion every 5 years
	Department of Agriculture, Weights and Measures	No license is needed from Weights and Measures, but a grocery store with scales must hire a <u>licensed service company</u> to <u>test the scales</u> once annually. Grocery stores with gas stations must hire a <u>retail fuel service company</u> to test the <u>fuel pumps</u> . Visit the <u>Weights &amp; Measures</u> website for more information, or call 785-862-2415.	Annual service
	Department of Agriculture, Pesticides and Fertilizers	Any retail business (including grocery stores, convenience stores and hardware stores) that retails pesticide products other than those ready-to-use general use pesticide products which:  (a) are to be applied undiluted, in accordance with use instructions shown on the pesticide's label; and  (b) are to be applied by homeowners or occupants to control pests in and around the family dwelling and associated structures; must complete the Pesticide Dealer Registration and Application.	Prior to July 1
	U.S. Department of the Treasury, Alcohol and Tobacco Tax and Trade Bureau (TTB)	Retail beverage alcohol dealers are required under federal law to fill out the <u>Alcohol Dealer Registration</u> . Consult the <u>TTB website</u> for more information, or to <u>apply online</u> .	Prior to opening
	Kansas Department of Revenue, Alcoholic Beverage Control (ABC)	Kansas law restricts the sale of alcohol in grocery stores to 3.2 beer only; Kansas grocery stores do not have to apply for a Kansas Liquor License as a result. Other forms may be required. It is recommended to <u>contact ABC</u> for further information at 785-296-7015. Other useful information regarding alcohol sales can be found on the <u>ABC website</u> . For the sale of cigarettes and tobacco, complete the <u>Cigarette Application License</u> and the <u>Business Tax Application</u> . More information can be found on the <u>Cigarette/Tobacco Products website</u> or by calling 785-368-8222 extensions 5 then 4.	Prior to opening, every two years for tobacco

	Kansas State Board of Pharmacy	Certain applications and forms are necessary to complete for sales on non prescription and prescription drugs. Review the full list of <u>applications and forms</u> , or contact 785-296-4056.	Varies
	Kansas Lottery	If selling lottery tickets, complete the <u>KS Lottery Application</u> . For more <u>information</u> call 1-800-322-5688.	
	U.S. Department of Health and Environment, Bureau of Air	Gasoline dispensing facilities are subject to a federal air regulation. Contact the Kansas Department of Health and Environment, Bureau of Air, at 785-296-1542.	Life of facility
	Department of Health and Environment, Bureau of Environmental Remediation, Storage Tank Section	There are multiple steps required for aboveground and underground storage tanks for grocery stores selling gasoline. Review the overview for aboveground and underground storage units. The Kansas Small Business Environmental Assistance Program (SBEAP) has program highlights and registration requirements. For permitting, call 785-296-6372.	August 1
	Kansas State Fire Marshall	For aboveground oil storage tanks, review the inspection <u>checklist</u> and complete the <u>Aboveground Storage Tank Application</u> . For more information, contact 785-296-8606.	Upon starting
